Levels Available: Beginner Novice through Advanced

Group Sizes: Friday, Semi Private Dressage: 2 riders per hour session
Saturday (SJ) and Sunday (XC): 4 riders per 2 hour session as necessitated by clinician's view for appropriate groupings.

Ride Times: Friday's flatwork sessions will be posted at www.dentoncreekfarms.com by January 19th, 2013.

Format:

The Saturday and Sunday morning sessions will be preceded with "coffee talk" with the clinician to lay out the days objectives. (Riders are strongly encouraged to attend to get the full benefit of this clinic.) Friday's flatwork sessions will start with more advanced riders to allow less experienced riders to become familiar with the clinician's style of instruction. Once the clinician has become familiar with the skill sets and levels of experience of the riders, we will have him establish the groupings for the following day.

Cost: (does not include stabling) \$500.00

Auditors are welcome and highly encouraged. Auditing slots will be limited and are available for prepayment before closing date at a charge of \$30/day or \$50 for all three days. Participating Riders who are **under the age of 18 must be accompanied by a parent or legal guardian** who will receive a complimentary auditing slot.

Lunch: A hot lunch will be available on grounds each day for purchase.

Prior to the closing date, should you not be able to attend the clinic, DCF reserves the right to fill the slot from the wait list. If there is no individual on the wait list able to fill the slot, you may sell your spot to another party. A refund of payments rendered minus a \$25.00 administration fee is available only if written notice is acknowledged and certified as received by the Denton Creek Farms before the closing date, otherwise there will be no refund.

Additional forms including release of liability waivers and medical information forms and a negative Coggins are required to be submitted by riders prior to the closing date, Auditors also must submit a completed USEA Educational Activity Release.
